

I am writing to express my profound objection to the proposed abolition of the federal electoral seat of Higgins in Melbourne. This decision, part of a redistribution to balance electoral representation due to population changes, threatens to dismantle a community with a rich history and distinct identity. As a resident of Stonnington, I feel compelled to highlight the numerous detrimental effects this change would bring.

Higgins has long been a cornerstone of Australian politics, producing notable figures such as Prime Ministers Harold Holt and Treasurer Peter Costello. In light of these concerns, I urge the Australian Electoral Commission to reconsider the decision to abolish the seat of Higgins. Maintaining the current electoral structure is crucial for the continued representation and well-being of Higgins residents. The unique identity, history, and contributions of Higgins to Australian politics should not be overlooked in the pursuit of numerical balance.
