Subject: Objection to the Abolition of the Federal Electoral Seat of Higgins

Dear Australian Electoral Commission,

I trust this message finds you well. My name is Frank A Robert, and I reside at South Yarra, South Yarra. I write to you today with a heavy heart and a profound sense of duty, compelled to voice my strong objection to the proposed abolition of the federal electoral seat of Higgins in Melbourne.

Higgins is not just a name on a map; it is the very fabric of our community, woven with threads of history, identity, and shared purpose. These relationships are the bedrock of effective advocacy and service. Disrupting them could lead to a period of adjustment where our needs and voices are less effectively communicated and addressed.

The potential for electoral confusion cannot be ignored. Voters may find themselves bewildered by new electorates, unfamiliar polling places, and representatives they do not know. This confusion could lead to decreased voter engagement and participation, undermining the very democratic process this redistribution aims to enhance.

Lastly, there are ongoing local projects and initiatives within Higgins that are tailored to our community's specific needs. These projects may lose momentum or be deprioritised under new representatives unfamiliar with our local landscape. The progress we have made, the goals we have set, and the future we envision for Higgins could be jeopardised.

In light of these concerns, I earnestly request the AEC to reconsider the decision to abolish the federal electoral seat of Higgins. Maintaining the current electoral structure is not merely a

matter of convenience; it is a matter of preserving the voice, identity, and future of the Higgins community.

Thank you for your attention to this matter. I remain hopeful that the AEC will recognise the importance of maintaining the integrity of Higgins for the benefit of all its residents.
