Declaration of interest: The author is a member of a political party (Pauline Hanson's One Nation) and has contested both State and Federal elections as a candidate of that party.

## Preface

The publication of the Determination on 27<sup>th</sup> July 2023; increasing the number of Commonwealth Electoral Divisions to which Western Australia is entitled, from 15 to 16, triggers the 3<sup>rd</sup> Redistribution in 10 years due to either increase or decrease the number of Divisions.

2014 from 15 to 16 Divisions

2020 from 16 to 15 Divisions

2023 from 15 to 16 Divisions.

Given WA is reverting to its configuration of just 3 years ago, there would be a temptation to simply undo many of the changes that were done in 2020-21, especially in the 3 rural Divisions.

But to do so without considering any population changes or trends of the last 3 years would not be doing this Redistribution justice.

## Part 1: New Divisional Name

Whilst reverting to how things were prior to the 2021 Redistribution, would prompt a reinstatement of the Divisional Name, Stirling, there are other factors to consider.

The likelihood is that the 16<sup>th</sup> Division is going to contain around 50% of Hasluck and around 50% of a combination of Swan, Canning, and Burt. This Division will be nowhere near where Stirling once existed.

There are relatively few retired Divisional Names for Western Australia.

Both Coolgardie and Kalgoorlie are retired Federation Division names. However, these are both locality-based and not relevant for reinstatement in this instance.

Other name-based Divisions include Dampier and the recently abolished Stirling. Again, I don't think the Committee will consider either worthy of reinstatement.

After some extensive research (initially in response to rumours that there was to be an expansion of the Parliament), I propose 6 names of prominent deceased Western Australians for the Committee to consider. One of which, I will include in my proposed changes.

Unlike NSW, with over 9 years of enrolment data from the existing Divisions, there is only 3 years of data for WA Divisions.

### Northern Metropolitan:

The six Divisions in this region were at 6.07 quotas at the commencement of the 2021-21 Redistribution and have remained at just over 6 quotas, and just over 6.4 quotas for 16 Divisions.

Projected enrolments for both Curtin and Hasluck show a mysterious reversal of trend enrolments for the past 3 years. The other 4 divisions projected enrolment numbers are not too far divergent from their trend enrolment.

### Southern Metropolitan:

The six Divisions in this region have been growing since the 2020 Redistribution. Starting at 5.94 quotas and growing to 5.98 by the 2022 Federal election and 5.99 quotas at the beginning of this Redistribution. This is projected to remain almost stable through to the projection date with 6.4 New quotas for 16 Divisions.

### Regional WA:

Between them, Durack, Forrest, and O'Connor have been sitting at between 2.96 and 2.98 quotas since the commencement of the 2020 Redistribution.

This grows to 3.16 New quotas meaning there will be some flow of electors from these 3 Divisions into metropolitan Divisions and the bridging Division of Canning.

### Step 3: Proposed new Divisional Boundaries

Unlike NSW, there are fewer obvious starting points in WA. However, by grouping the Divisions into three groups as I have, it becomes obvious that either the northern or southern suburbs need to be the starting point.

I have chosen to start with Curtin in the north. Divisional boundaries will contract westwards and Durack, the largest Division in the State will exit the Swan LGA and the Greater Perth GCCSA on Community of Interest grounds.

On raw numbers alone, only Burt and Forrest are within projected tolerances, but the flow of surplus electors from other Divisions will ensure that all 15 current Divisions end up having at least one boundary change.

**Where proposed Divisional boundaries do not align with current LGA boundaries (& even for some that do); maps of the proposed changes are supplied. These maps are indicative only and should be used in conjunction with the written description to determine the boundary changes proposed.**

### Northern Metropolitan Divisions

#### Curtin

Curtin needs to reduce its enrolment. Whilst most of its boundaries are generally strong boundaries, the part of Curtin to the north of Karrinyup Rd was an area that immediately stood out as an opportunity to reduce enrolment.

#### Boundary Changes:

##### Between Curtin and Moore

From the existing boundary at the intersection of Karrinyup Rd and Marmion Ave; ESE along Karrinyup Rd to the existing boundary (Mitchell Fwy/Butler Rail line).




Image 1 – Proposed Curtin – Moore boundary

## Moore

Having gained from Curtin, Moore had to reduce its enrolment.

With Pearce to Moore's north and east also needing to lose electors, the most appropriate block of electors to transfer out were the electors of Kingsley.




Image 2 – Proposed Cowan – Moore boundary

## Pearce

Pearce is proposed to become a wholly Wanneroo LGA-based Division. It's Swan LGA component is transferred to Hasluck.

It's new southern boundary in Wanneroo LGA through Madeley, Darch and Landsdale follows the line of Kingsway, Tony Martin Way and Denman Gardens.

### **Boundary Changes:**

#### **Between Cowan and Pearce**

From the intersection of Wanneroo Rd and Kingsway, Madeley; east along Kingsway and continuing that line through Tony Martin Way, Denman Gardens and back to Kingsway through to Alexander Drive and the Wanneroo – Swan LGA boundary.

#### **Between Hasluck and Pearce**

The Divisional boundary aligns with the Swan – Wanneroo LGA boundary so that the part of Swan LGA currently in Pearce is transferred to Hasluck.




Image 3 – Proposed Cowan - Hasluck – Pearce boundary

## Cowan

With surplus electors from Moore and Pearce already gained, Cowan needed to lose electors in its east.

The obvious place to reduce Cowan's enrolment was east of the Tonkin Highway, though this didn't bring Cowan back to tolerance.

In Cowan's SW corner, its boundary with Perth is to be simplified.

The part of Cowan east of the Tonkin Highway is transferred to Hasluck




Image 4 – Proposed Cowan – Hasluck boundary




Image 5 – Proposed Cowan – Perth boundary

Perth

Second only to Cowan, in both current and projected electors, in the northern metro Divisions, Perth's gains in its west means losing electors in its east to Hasluck.




Image 6 – Proposed Hasluck – Perth - Swan boundary

## Hasluck

Hasluck gains parts of the Swan LGA from both Pearce and Durack. With the flow of electors from Divisions further west, Hasluck's existing electors in Mundaring and Kalamunda LGA's are now surplus to requirements.

With 49,832 current and 52,624 projected electors' surplus, these flow to the new Division to be created at the eastern end of the Greater Perth GCCSA.

From the six names I suggested in Part 1 of this submission, I have chosen, on merit alone, Chaney as my proposed new Divisional name.

I believe that of all the names I suggested, Fred Chaney's service to his country is the most meritorious of those I nominated.

From where the Helena River is crossed by the Roe Highway at the Bellevue – Helena Valley locality boundary; NNE along the Roe Highway to Morrison Rd, Midvale, and the Swan LGA boundary; thereafter, aligning with the Swan LGA boundary NE to the intersection of the Swan, Mundaring, and Toodyay LGA boundaries.

## Between Hasluck and Swan

From the existing Hasluck – Swan boundary on the Swan River (also Ascot – South Guildford locality boundary), upstream along the Swan River to the Helena River; upstream and eastwards along the Helena River to the Roe Highway.

## Forrest

Having gained the heavily forested (pun intended) SW corner of the State from O'Connor; Forrest transfers the majority of Harvey Shire to Canning. Numeric considerations prevented the entire Harvey Shire being transferred to Canning.

### Boundary Changes:

#### **Between Forrest and O'Connor**

#### **Between Canning and Forrest**

The boundary between Canning and Forrest within Harvey LGA is as follows: From where the Forrest Highway crosses the Collie River; north along the Forrest Highway/Australind Bypass to the Brunswick River; ENE along the Brunswick River and aligning with the Brunswick locality boundary along the Wellesley River to Marriott Rd; initially east along Marriott Rd, though diverging to align with the Brunswick locality boundary in a clockwise direction until it intersects the Harvey – Collie LGA boundary.

The part of Harvey Shire to the SE of this boundary which appears to contain the localities of Brunswick, Beela, and Roelands remains in Forrest.




Image 8 – Proposed Canning – Forrest boundary

## Southern Metropolitan Divisions

### Canning

Canning is WA's bridging Division, bridging from the urban fringe to regional WA.

The current version contains electors from Kalamunda, Gosnells, Armadale, Serpentine-Jarrahdale, Mandurah LGA's, and the developed western half of Murray LGA which are part of the Greater Perth GCCSA. It's current regional components are limited to the Waroona LGA and eastern, forested half of the Murray LGA.

The gain from Canning of the majority of Harvey LGA allows Canning to shed all its territory and electors north of, and including Serpentine-Jarrahdale LGA.

Canning also acquires a part of Rockingham LGA from Brand to balance the numbers in both Divisions.

#### **Boundary Changes:**

##### **Between Canning and Forrest**

Refer Forrest.

##### **Between Canning and Chaney**

The Serpentine-Jarrahdale – Murray LGA boundary aligns with the proposed Canning – Chaney Divisional boundary. All territory and electors to the north of this boundary are transferred to Chaney.

##### **Between Brand and Canning**

The localities of Golden Bay, Singleton, and the Karnup SA2 are transferred from Brand to Canning.




Image 8 – Proposed Brand – Canning boundary

## Brand

The current version of Brand neatly incorporates both the Kwinana and Rockingham LGA's in their entirety. However, when dividing by 16 Divisions instead of 15, Brand has too many electors and needs to reduce enrolment.

Immediately to Brand's north, Fremantle also has a strong southern boundary aligning with the Cockburn LGA boundary.

I felt the least impact would be to transfer electors in the southern part of Rockingham LGA to Canning, rather than in the northern part of Kwinana LGA to Fremantle.

## Fremantle

Fremantle needed to reduce enrolment, though requires a relatively minimal change. I propose to transfer the locality of Palmyra in its entirety from Fremantle to Tangney to bring Fremantle's enrolment back within tolerance.

### Boundary Changes:

#### Between Fremantle and Tangney

The locality of Palmyra is transferred from Fremantle to Tangney so that the Divisional boundary aligns with the Melville LGA boundary.




Image 9 – Proposed Fremantle - Tangney boundary

## Tangney

Needing to reduce enrolment I propose an exchange of electors with Burt to simplify the Burt – Tangney boundary.

With both the Roe Highway and Canning River forming part of Tangney's existing boundary, I propose to continue that with Burt.

### Boundary Changes:

#### **Between Fremantle and Tangney**

#### **Between Burt and Tangney**

From where the Roe Highway is traversed by the Canning – Melville LGA boundary, Leeming; continuing NE along the Roe Highway to the Canning River, then NW along the Canning River to Nicholson Rd and the existing Burt-Swan-Tangney Divisional boundary.

IE the locality of Langford is transferred from Burt to Tangney, the locality of Canning Vale is transferred from Tangney to Burt.




Image 10 – Proposed Burt - Tangney boundary

## Swan

Needing to reduce enrolment, the most obvious feature of Swan's boundary worthy of adjustment was its awkward eastern boundary around Maida Vale, Forrestfield, and Wattle Grove.

I propose this is pared back to the Roe and Tonkin Highways.

In addition, Swan gains from Hasluck the localities of South Guildford and Hazelmere west of the Roe Highway.

### **Boundary Changes:**

#### **Between Chaney and Swan**

From where the Roe Highway crosses the Helena River; SSW along the Roe Hwy; SE along the Tonkin Hwy to the existing boundary where the Gosnells – Kalamunda LGA boundary aligns with the Tonkin Hwy.

#### **Between Hasluck and Swan**

From the existing Hasluck – Swan Divisional boundary, where the Ascot – South Guildford locality boundary meets the Swan River; upstream (NE) for approximately 2KM along the Swan River to the Helena River; eastwards along the Helena River to the Roe Highway.

## Burt

Having already gained Canning Vale from Tangney and transferred the locality of Langford to Tangney, Burt needed to significantly reduce its enrolment.

Transfers to the proposed new Division of Chaney on Burt's eastern and southern boundaries return this Division to enrolment tolerance

1. The locality of Orange Grove is transferred to Chaney.
2. The locality of Mount Nasura and part of Kelmscott east of the Albany Highway are transferred to Chaney.
3. The part of Armadale east of the intersection of the Albany and South Western Highways is transferred to Chaney.
4. From the intersection of the Albany and South Western Highways, the Burt – Chaney boundary turns west along Armadale Rd, then south on the Tonkin Highway to the existing boundary at the intersection of Rowley Rd.




Image 43 – Proposed Burt – Chaney boundary

## Chaney

Chaney becomes the 16<sup>th</sup> Division in WA, gaining electors from the existing Divisions of Burt, Canning, Hasluck and Swan.

### **Boundary Description:**

Despite being described elsewhere in this submission, it's worth having the entire boundary described in one place. Starting in Chaney's NW corner and moving clockwise, the boundary runs thus:

#### **North boundary**

From where the Roe Highway crosses Morrison Rd, Midvale, aligning with the Swan - Mundaring LGA boundary; continuing along the Swan – Mundaring LGA boundary NE to the intersection of the Swan, Mundaring, and Toodyay LGA boundaries.

#### **East boundary**

Southwards, aligning with the eastern LGA boundaries of Mundaring, Kalamunda, Armadale, and Serpentine-Jarrahdale LGA's, to the intersection of the Serpentine-Jarrahdale, Murray and Wandering LGA boundaries.

#### **South boundary**

Westwards along the Serpentine-Jarrahdale – Murray LGA boundary to the Rockingham LGA boundary.

#### **Western boundary**

Northwards along the western LGA boundary of Serpentine-Jarrahdale until it meets the Armadale LGA boundary at Rowley Rd; east along the Armadale - Serpentine-Jarrahdale LGA boundary to the Tonkin Hwy; north along the Tonkin Hwy to Armadale Rd; east along Armadale Rd to the intersection of Armadale Rd, Albany and South Western Highways; north along the Albany Highway to the Gosnells LGA boundary; briefly NE along the Gosnells – Armadale LGA boundary to the Canning River; north along the Canning River until it's crossed by the Tonkin Highway; north along the Tonkin Highway to the Roe Highway; NNE along the Roe Highway to Morrison Rd, Midvale.
