

## Synopsis

This is a written suggestion under subsection 64(1)(a) of the *Commonwealth Electoral Act 1918* for the redistribution of Western Australia. This suggestion covers both the names and boundaries of all divisions within Western Australia.

Every redistribution is an opportunity to evaluate community of interests and provide some scope for improvement. Likewise, the names of existing divisions should be examined at every redistribution to ensure that they continue to recognise the contributions of worthy Australians, and that those honoured exhibited values and deeds that reflect modern Australian society.

In determining the division boundaries and names, I consider the [Guidelines for making public submissions to a redistribution](#) and the [Guidelines for naming federal electoral divisions](#). I apply my own principles in relation to retaining federation names and aim to increase diversity of representation if names of divisions are to be created, renamed or retired.

I propose no changes are made to **FORREST**, **CANNING** retreats to the Serpentine-Jarrahdale boundary, taking additional territory east of the Kwinana Fwy from **BRAND**. A minor transfer of electors occurs from **FREMANTLE** to **TANGNEY** which then takes in Langford and gives Canning Vale to **BURT**. Further exchanges with **BURT** losing everything north of the Canning River to **SWAN**, and everything east of the Albany Hwy to the new division.

North of the Swan River, **CURTIN** moves back to Karrinyup Rd, while **COWAN** crosses the Mitchell Fwy to gain Gwelup and the rest of Karrinyup from **MOORE**. **PEARCE** loses the territory in Swan and Kingsway in Madeley and Landsdale marks the southern border. **COWAN** and **PERTH** both use the Tonkin Hwy as the eastern boundary, giving everything east to **HASLUCK**.

Using the Great Eastern Hwy Bypass, Roe Hwy, Toodyay Rd and City of Swan boundary, **HASLUCK** moves to the north, while the areas in the south of Hasluck are added to the areas of **SWAN** east of the airport and areas in **BURT** north of the Canning River and the addition of Northam, York and Beverley.

To balance the numbers in **DURACK** and **O'CONNOR**, a few exchanges are made between the two along the existing boundary.

Finally, I propose the new division to be named **BATES** in honour of journalist and author Daisy May Bates CBE.

## Introduction

### About this suggestion

This redistribution commenced in accordance with subsection 59(2)(a) of the *Commonwealth Electoral Act 1918* (the Electoral Act) as the number of members of the House of Representatives to which Western Australia is entitled changed, following the entitlement determination made under subsection 48(1) on 27 July 2023.

The entitlement determination requires that Western Australia increase its electoral representation by one seat, to 16 seats. As a result, Western Australia has changed its electoral representation, in three of the last four determinations, changing from 15 to 16 seats in 2014, dropping back to 15 in 2020 and now returning to 16 divisions.

Ordinarily, the creation of a new electoral division necessitates a more radical redistribution than one occurring as a result of the passage of time. However, as Western Australia underwent a redistribution only three years ago, most of the divisions are relatively stable. Having said this, they are almost entirely over the projected threshold, so will need to lose electors to return within the acceptable quota.

Every redistribution is an opportunity to evaluate the existing boundaries to determine the extent that they meet the community of interests grounds of subsection 66(3)(b) of the Electoral Act. In most cases, existing divisions ultimately contain deficiencies in community of interests grounds resulting from the numerical restraints imposed in subsection 66(3)(a) of the Electoral Act. As such, there will almost always be some scope for improvement.

### Enrolment data

In order to comply with the numerical requirements of the Electoral Act, the number of electors enrolled in each division must not vary by more than 10 per cent from the redistribution quota. The Electoral Commissioner has determined the redistribution quota for Western Australia on 9 August 2023 to be 113,508 electors. This means that no division can contain more than 124,858, or less than 102,158 electors.

The projected number of electors must, as far as practicable, be within 3.5 percent of the quota of 121,615 on the projection date of 24 March 2028, meaning divisions must contain between 117,359 and 125,871 electors. The numerical tolerances under subsections 66(3)(a) and 66(3)(b) of the Electoral Act are the only mandatory criteria, so these figures supersede any other community of interests factors and the numerical tolerance must be maintained.

## Methodology

### Determining boundaries

In drafting this suggestion, I have endeavoured to comply with the requirements of subsection 66(3)(b) of the Electoral Act, taking into account:

- i. community of interests, including economic, social and regional interests;
- ii. means of communication and travel;
- iv. the physical features and area; and
- v. the boundaries of existing divisions within the State.

I attempt to use clear boundaries wherever possible to ensure that electors can easily identify the division in which they live. I will split SA1 areas where a geographic feature makes for a more logical division boundary. In cases where split SA1 elector data is not available, I make a judgement call as to which division I include the electors. More accurate information should be available for the Committee to ensure all divisions fully comply to numerical constraints. In these cases, I aim to ensure that either division could afford the entire SA1 population within the numerical threshold.

In order to obtain the best communities of interests, I intend to make use of the full tolerance of the quota and enrolment in several divisions will be close to the threshold. I believe that the threshold under subsection 66(3)(a) exists for a reason, and should be used to the full extent where its use achieves better representation for electors. I know there is a trend to ensure areas with particularly high or low growth are balanced, in the hopes that a future redistribution could minimise changes. I do not believe this is necessary. Often the projected number fail to accurately predict the actual growth patterns, and as a result, any future redistribution conducted will generally readdress these concerns at the time.

Unless explicitly specified, references to elector numbers refer to projected enrolment figures, as this is generally the stricter criterion used in determining electoral boundaries.

In the main, this is a cascading process. I will start with an “anchor” division, usually in the corner of the state, or in an area with few options to expand or shed electors. From this division, the electors are shifted in a cascading manner from one division to the next until all divisions are updated.

### Boundaries of existing divisions

I intend to use the existing divisions as building blocks of my suggested divisions. However, in doing so, I note that under section 66(3A) of the Electoral Act, the existing boundaries are considered subordinate to the other criteria. Hence, the existing boundaries should always yield to community of interests grounds where the existing boundary would otherwise divide a united community and the numerical tolerance allows.

## Community of interests

Defining a community of interests can be ambiguous and is often the subject of debate within suggestions and objections. For the most part, a single community of interests is nothing more than a group of residents who share similar amenities, socialise or organise themselves into communities, share similar socio-economic demographics, live close by to one another, or otherwise identify as a community. It is highly unlikely that an electoral division will contain only one community of interests. In most cases, a division shall comprise several similar or interrelated communities.

Local government areas can be a good indicator of communities of interests, particularly in rural and regional areas. Often townships share amenities across government areas and residents share similar professions, socio-economic or cultural demographics.

This is less so in metropolitan areas. Given the more fluid movement of residents in these areas, and shorter comparative distances, communities of interests often span local government boundaries. Furthermore, local government areas can often be anachronisms from history, or recent artificial amalgamations that, at times, bear little resemblance to the local communities of interests. For these reasons I am less willing to keep local government areas intact in metropolitan areas.

Suburb or locality boundaries can often be arbitrarily defined or unclear. They frequently make use of lines of sight, or ambiguous property boundaries. However, it is apparent that previous Committees have seen the usefulness in using them as division boundaries. As such, I will use suburb and locality boundaries where it is convenient and appropriate. Particularly within regional areas, a strong geographic boundary can often be difficult to come across, so a locality boundary can make more sense.

## Communication and travel

Means of communication and travel must be considered when determining boundaries for electoral divisions. Where separate communities need to be combined into a single division, it is always preferable that this occur along transport corridors such as highways, main roads or railways. Creating divisions that are only contiguous on a map, but not connected with transport or communication corridors inevitably leads to some electors feeling disconnected from the rest of their community and, indeed often their local representative.

While major roads, railways or rivers can be used as boundaries to a great extent, care must be taken to ensure that a boundary is not drawn down a road or railway that actually unites communities. More common in rural areas, sometimes a railway station or major road will become a community hub with electors and residents from either side accessing the facilities.

### Physical features and area

Physical features can often be used to determine boundaries. Often they impose severe barriers on communication and serve as natural boundaries. Rivers, bays, mountains and large bushland areas lend themselves to creating natural and convenient boundaries.

Inevitably at some point, the boundary will be drawn – probably down a street, railway or suburb boundary – where it, in fact, divides a community of interests. There will be residents that live either side of a given boundary that share a greater affinity with those on the other side of the line than with those that further afield within the division they have been assigned. This cannot be completely avoided, as the very nature of a redistribution means that a line must be drawn on a map somewhere. I strive to ensure that where a line is drawn, it is generally recognised as a local boundary, or logically could sensibly be interpreted to be one.

### Political fairness

I determine electoral division boundaries in a wholly impartial manner. As far as I consider, this means disregarding potential political implications for divisions or for members representing these divisions. I do not attempt to make myself aware of voting patterns at particular booths or within specific localities to avoid this bias influencing my decisions.

Political support or affiliation is not included as a criterion within section 66 of the Electoral Act, and I believe this omission was deliberate. I do not believe political support should form any part of the consideration of electoral boundaries. Any idea of fairness should be interpreted to mean without regard to political implications, rather than adding a complication of balancing ever-changing political ideologies among voters.

## Division Names

### Divisions named for colonial-era persons

Every redistribution provides an opportunity to ensure that divisions not only reflect communities of interests in drawing boundaries, but also that the names of the divisions reflect standards that are acceptable to contemporary society and the community.

According to the [Guidelines for naming federal electoral divisions](#), in the main, divisions should be named after deceased Australians who have rendered outstanding service to their country.

Not surprisingly, an inordinately large number of divisions are named after colonial-era politicians, governors, pioneers or explorers. Several of these individuals – while making a contribution to, and even laying the foundations of, the Australia we know today – would hardly have considered themselves to be Australian. The appropriateness of some of these individuals to continue to receive recognition is, at best, obsolete, and, at worst, questionable.

This is especially true when considering that many of the individuals are recognised in many other aspects of society, through the names of local government areas, suburbs, roads and highways, geographic features such as mountains, rivers and bays, private and public institutions including military installations, universities, hotels, airports, banks or hospitals, public buildings or landmarks already honour these individuals. Many of these individuals are honoured with numerous legacies for them for example, the plethora of monuments and features dedicated to Maj. Gen. Lachlan Macquarie, Capt. James Cook or Capt. James Stirling.

Largely, these colonial-era persons are men of European – primarily British or Irish – descent. So, it has been heartening to see a genuine attempt to address this diversity imbalance with division names in recent years being named for women, families that include women or indigenous persons. Some effort could still be made toward other people of non-European ethnicities, however I am hopeful this will come with time as these groups become more prevalent in Australian society.

Increased diversity of division names should be encouraged to continue. When renaming or abolishing divisions, we should look to remove divisions named for colonial-era men of European descent over divisions named for more contemporary or diverse individuals. This should apply particularly if the individual in question would have considered their nationality to be British, or has many other monuments in their honour. If it becomes inevitable that a division honouring a woman, indigenous person or other person of diverse background is to be abolished, we should look to renaming another nearby division to retain the name. There is precedent for this practice, with the division names **REID**, **HUNTER** and to some extent **COWAN** being retained where it could otherwise be expected that the division was to be abolished.

We have also seen a several divisions renamed when the conduct of those for whom the division is named has been called into question. In these cases, especially in the wake of ongoing practices worldwide, we should use the opportunity of a redistribution to rename divisions where it comes to

be known that such individual conducted themselves in a way not deserving the honour of a division name. This is the case, to varying extent, with the former divisions of **BATMAN**, **McMILLAN**, **STIRLING**, **WAKEFIELD** and **DENISON**.

### Federation divisions

Federation divisions pose another problem. For the sake of clarity, federation divisions shall be taken to include the divisions in South Australian and Tasmanian that were used for the 1903 election.

The guidelines recommend avoiding abolition or renaming of federation divisions. This guideline will likely need to be revisited in the future. The obvious and deserved inclusion of divisions named for prime ministers along with attempts to include more diversity in division names ultimately leads to either geographic or colonial-era divisions becoming candidates to rename. Not coincidentally, the majority of federation divisions are geographic or named for colonial-era persons.

We can already see problems geographic names cause. **WERRIWA** has not included its namesake – Lake George – for decades. There were strong objections at recent redistributions where the divisions of **PARRAMATTA** and **PERTH** were proposed without including the respective cities and the divisions of **CORANGAMITE**, **RICHMOND** and **RIVERINA** cover areas further away from their namesakes with every redistribution. The division of **PORT ADELAIDE** was also retired as a geographic name that also duplicated a state electoral division. The division of **CHARLTON** had to be renamed **HUNTER** to ensure a federation division name continued.

It may well come a time where this policy to retain federation division names becomes unviable. Even the various Redistribution Committees have felt it necessary to violate the policy at least five times since 2006, abolishing or renaming federation divisions in every state<sup>1</sup>, save Queensland.

Given the reasons above, I don't feel inclined to continue to adhere to this policy in cases where it is apparent that an existing federation division name is less suitable than another name for a division.

## Division names in Western Australia

The division of **CURTIN** is named for a former prime minister and this alone ensures that the name continues.

Three of Western Australia's divisions are remaining federation divisions – **FREMANTLE**, **PERTH** and **SWAN**. All three are geographic in name, **PERTH** and **SWAN** named after the city and the river respectively, with **FREMANTLE** being named after the city, which in turn, is named after the British naval officer who made landfall and claimed Western Australia for Great Britain.

Only two divisions in Western Australia – **COWAN** and **TANGNEY** – are named solely for women, although the divisions of **HASLUCK** and **DURACK**, are named for a husband and wife, or families including women. The division of **BURT** is named for a family, but not specifically for any women within the family.

The division of **CANNING** was rededicated in 2021 to be named for an indigenous woman in addition to the long standing recognition for an man of European descent.

The divisions of **BRAND** and **PEARCE** are named after the longest serving state premier and a federal Cabinet minister with an extensive career.

**FREMANTLE**, along with **MOORE**, **O'CONNOR**– are named for early explorers or settlers born in Great Britain or Ireland and, who by historical record, would not have considered themselves Australian. Likewise with the recently abolished division of **STIRLING**.

**FORREST** is named after an individual born in Australia who has numerous other legacies named in his honour within Western Australia.

## Divisions proposed to be abolished or renamed

As Western Australia gains an electoral division, no current divisions need to be abolished. I also do not see the need for any existing division names to be retired, as no divisions change so extensively that the existing division name is no longer recognisable.

Should the Committee wish to recognise more individuals of diverse backgrounds and simply rename an existing division, I would suggest the candidates come from the divisions of Forrest, Fremantle, Moore, O'Connor as divisions named after colonial-era persons, or Swan as a geographic name.

## Name for the new division

Perhaps the most straightforward solution for this redistribution would be simply to reinstate **STIRLING** as a division name. However, this is problematic for a number of reasons. If the new division is located in a different part of the state to the old division, it could lead to confusion for electors. This would be further exacerbated by the presence of the City of Stirling partially overlapping the territory of the old division. Furthermore, as already mentioned above, it has been

identified that actions of Capt. James Stirling in the past means it is no longer appropriate to name a division after him. So, we once again search for prominent Australians from Western Australia.

As I suggested in [my submission](#) into the 2016 redistribution, I would still consider nominating Herbert Cole “Nugget” Coombs PhD<sup>2</sup> as a candidate. Born in Kalamunda in the Darling Range, he was a native of Western Australia. As a leading public servant and adviser to prime ministers of both political persuasions, his influence in many areas of public administration and government policy are still reflected in modern Australia. Along with his advocacy of the arts and, particularly, the welfare and rights of First Nations people, his accomplishments more than merit an electoral division being named for him.

However, I note there seemed to be little enthusiasm for my proposal at the last redistribution, with no comments supporting my suggestion. It also seems that many suggested names – save the obvious political suggestions – are in favour of naming divisions after women or indigenous persons. As I support this movement for greater diversity, I suggest maybe Coombs, while worthy, is now not the best choice for a new division name.

In lieu of the proposal for a division named **COOMBS**, I suggest a division could be named **BATES** in recognition of Daisy May Bates CBE<sup>3</sup>. Born in Ireland as Margaret Dwyer, her chequered early life ultimately led her to Western Australia. She became interested in the lives and treatment of First Nations people and devoted 40 years of her life to studying Aboriginal life, history, culture, rites, beliefs and customs. From contemporary accounts she never tried to teach or convert any First Nations peoples but rather studied their customs and languages. She became one of the most distinguished scholars on the lives of Western Australian First Nations peoples. She was an inaugural inductee to the WA Women’s Hall of Fame<sup>4</sup> in 2011.

Her name has been suggested several times in the past, and I believe that her accomplishments would certainly merit a division named in recognition of those accomplishments.

I propose that: A new division in Western Australia be named **BATES** in honour of Daisy May Bates CBE.

## Analysis of existing divisions

### Geographic arrangement of divisions

The major geographic boundary in Western Australia's electoral divisions is the Swan River. This is crossed by the City of Fremantle at the mouth, and again inland within the City of Swan. The Darling Range to the east is a significant barrier, however these are more easily traversed than similar ranges in the eastern states, and areas both sides of the range are similar in demographics and community. In many rural areas local government boundaries are the best method for determining boundaries.

Roads and highways tend to serve as major boundaries within Perth, with the Roe, Reid and Tonkin Highways, the Mitchell and Kwinana Freeways serving as barriers to communication and travel.

The recent redistribution went a long way to solving many issues with Western Australia's electoral boundaries. In particular, the current division of **PEARCE** is a significant improvement on the previous arrangement. The only real issue now is the way **CANNING** wraps around **BURT** to the east, with parts of the Cities of Armadale, Gosnells and Kalamunda disconnected from the rest of the Division.

It would also be preferable to excise the remaining parts of the City of Swan from **DURACK**, as this division stretches all the way from the outskirts of metropolitan Perth to the top of the north west of the state.

If anything else, the existing division of **FORREST** could expand to reclaim areas in the south, such as the Shires of Nannup and Manjimup. However, this appears unlikely as the electoral data indicate that **FORREST** would be unable to gain additional electors.

## Suggested divisions

Starting in the south west of the state **FORREST**, is within tolerance, but close to the top limit of electors. I investigated the option of returning Nannup Shire but this takes **FORREST** over the threshold. Not wanting to expand **CANNING** any further south to accommodate this exchange, I leave **FORREST** alone.

Moving east, I calculate that the three rural divisions of **FORREST**, **O'CONNOR** and **DURACK** can jointly afford to lose up to 32,000 electors, and must lose at least 6,892 electors.

As I'm leaving **FORREST** untouched, the excess electors need to come from **O'CONNOR** and **DURACK**. The obvious place to start is within the City of Swan and all of Bullsbrook and the associated National Parks result in 4,314 electors moving. As further electors are still required to be transferred, all of Northam, York and Beverley Shires are transferred. The Shire of Toodyay should probably be transferred along with Northam, however it would leave **DURACK** at the bottom of the threshold, and based on the other movements later on, would lead to an unwieldy shaped division. For this reason, Toodyay stays within **DURACK**.

To balance the numbers, the Shires of Cunderdin, Kellerberrin, Koorda, Merredin, Mount Marshall, Mukinbudin, Nungarin, Tammin, Trayning, Wiluna and Wyalkatchem are moved into **DURACK**. This then leaves **DURACK** at the quota, and **O'CONNOR** just slightly below.

Moving into the Peel area, **BRAND** needs to lose electors, so transfers electors to **CANNING** using the Kwinana Freeway as a single, strong boundary. This then allows **CANNING** to shed all electors in the Cities of Armadale (save for the diversion around Hilbert), Kalamunda and Gosnells.

**FREMANTLE** can afford to drop all of Palmyra, which brings it within tolerance. **TANGNEY**, taking Palmyra, then transfers all of Canning Vale, with electors there being disconnected from the rest of the division by the commercial district. A further exchange is then made with Langford being transferred in. These exchanges of Canning Vale and Langford to **BURT** leave it over threshold, so it loses everything north of the Canning River and east of the Albany Highway.

**SWAN** then picks up all of Beckenham, Kenwick and part of Maddington, using Kelvin Rd and Maddington Rd as a boundary. Then using Tonkin Highway and the railway line along the airport, part of Wattle Grove and all of Forrestfield, High Wycombe and Maida Vale is transferred out.

Moving north of the Swan River, a simple exchange of electors drops **CURTIN** back to Karrinyup Road for its northern boundary. The areas formerly in **CURTIN** go into **COWAN**, along with the rest of Gwelup and all of Carine from **MOORE**. While this means **COWAN** crosses the Mitchell Freeway, there are shared communities in this area. This area is all contained within the City of Stirling, so these areas share amenities. Beach Road, Reid Highway, Erindale Road and Karrinyup Road all act as transport corridors and enable communication between these areas. Furthermore, these areas were previously united in the electoral division of **STIRLING** until only the last redistribution in 2021.

**COWAN** still needs to take a few more electors to help bring **PEARCE** under threshold, so using Kingsway as a straight and logical boundary through Madeley, Darch and Landsdale, along with aligning the eastern boundary of Pearce with the City of Wanneroo boundary, **PEARCE** is now within tolerance. **COWAN** then also sheds everything east of Alexander Drive, and all of Ballajura, splitting Malaga, using Beach Road and Marshall Road.

This enables the Tonkin Highway to be used as a boundary along its entire length from the Swan River to Marshall Road. This serves as the eastern boundary for both **COWAN** and **PERTH**, however using this boundary means **PERTH** becomes slightly under threshold, so an additional exchange is still needed. Not wanting to cross this established boundary, or the already established strong boundary of Morely Drive, **COWAN** cedes its section of Osborne Park and Stirling to **PERTH**, using Karrinyup Road and Cedric Street as the boundary.

This then leaves an area bound by the boundaries of the City of Swan, the Shires of Mundaring, Northam, York, Beverley, the City of Armadale, the Albany Highway, the Tonkin Highway, Canning River, Kelvin Road and Maddington Road, back to the Tonkin Highway, along the railway line, the Great Eastern Highway Bypass, the Swan River, the Tonkin Highway again, Marshall and Beach Roads.

The existing division of **HASLUCK** is located entirely within this area. Combing the extra areas transferred from **BURT**, **CANNING**, **COWAN**, **DURACK**, **O'CONNOR**, **PEARCE**, **PERTH** and **SWAN**, this area is now large enough to split into two. The Great Eastern Highway Bypass, Roe Highway, Toodyay Road and the local government boundary between the City of Swan and the Shire of Mundaring make for a strong, clean boundary. We now need to make a decision about which division to name **HASLUCK** and which to give the new name. As 68,429 current electors from **HASLUCK** move into the northern division, and only 54,426 current electors move into the southern division, the northern division is therefore named **HASLUCK**. The southern division is subsequently named **BATES**, in honour of Daisy May Bates.

## Enrolment data for each electoral division

Each division is listed separately with a table outlining the actual and projected enrolment, by SA2 names. Each table in order, lists all electors retained in the division, and then describes the transfer into the division by alphabetical order of existing division name, and then out of the division in alphabetical order by new division name.

A description of the changes to the division boundary follows, proceeding in a clockwise manner using geographic features or infrastructure to describe the boundary where possible. In some cases, the existing boundary is redundantly described where it is followed for a short period before deviating again.
